### OVERVIEW

Doug is a former Senior Assistant Attorney General of the State of Florida's Economic Crimes (Antitrust) Division and has more than 20 years' experience advising clients with internal investigations and creating compliance policies and systems to reduce the risk of government enforcement actions. Doug has earned the ANSI-accredited Certified Information Privacy Professional/United States (CIPP/US) credential through the International Association of Privacy Professionals(IAPP). He regularly advises companies on a variety of privacy law matters, including digital marketing, website privacy compliance, and biometric data collection.
