## Shareholder Melanie Leitman Elected Vice President of America's Second Harvest of the Big Bend

In addition to Melanie's involvement, the firm's Tallahassee office regularly volunteers for the organization, including packing bags for children enrolled in a supplemental weekend feeding program that ensures children receive a healthy breakfast, lunch, and snack every weekend during the school year. In addition to her involvement with Second Harvest, Melanie is a leader in several other organizations positively impacting the Tallahassee community. She is a Co-Founder and Director of the Bridge to Law School Program, an initiative that integrates academic preparation, mentoring, and professional development to demystify the law school application process, the law school experience, and the practice of law for first-generation college students. The program was recently honored with two Diversity & Inclusion awards, including the Daily Business Review's 2024 Florida Legal Awards and the 2023 Tallahassee Women Lawyers Diversity & Inclusion Leadership Award. Melanie also serves as Treasurer of the William H. Stafford American Inn of Court and is a member of Tallahassee Women Lawyers (TWL).
