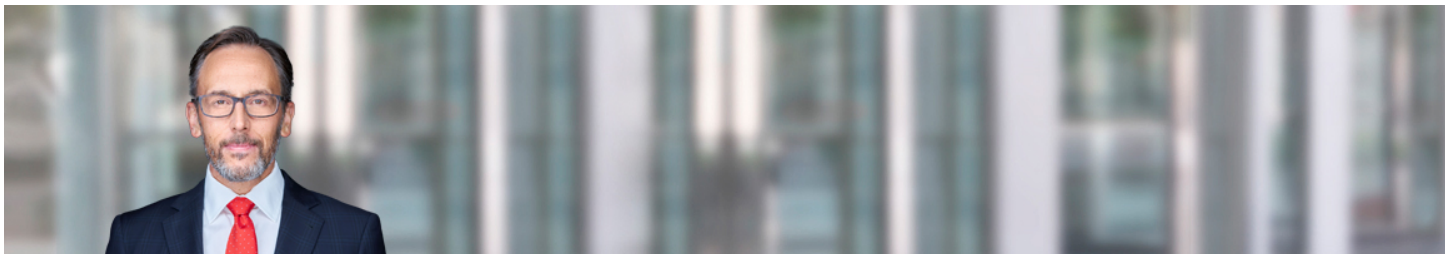

### OVERVIEW

Andrew Rodman is a Shareholder in the Firm's Labor & Employment Law Department and a member of the Firm's Board of Directors. Andrew's labor & employment law practice encompasses both counseling and litigation on behalf of employers.

On the counseling side, Andrew takes pride in developing working partnerships with his clients to analyze problems and implement practical solutions to the broad range of issues that executives and Human Resource professionals regularly encounter. Andrew also represents clients in non-compete, trade secret, and employment contract litigation.

Andrew conducts management training and internal audits for clients as preventative measures aimed at avoiding internal complaints, administrative

investigations, and costly litigation.
