Led global sports betting company's multidisciplinary statewide investigation into referendum ballot tampering and petition blocking relating to the Florida Casino Gaming Expansion Initiative. The 1inMM Ponzi Scheme generated approximately \$700 million in fraudulent investments for Hollywood movie deals primarily steered by Zachary Horowitz with the assistance of multiple fund aggregators. Multiple accredited investors found themselves barred from suing the fund aggregators and began suing other individual investors in Florida to try to recoup their funds. Shortly after suit, the federal court dismissed the action for a patent lack of jurisdiction.
